III. Measures

Conditions

- o General availability of masks and disinfectant gel
- Regular disinfecting of spaces
- o Reduced maximum occupancy
- o Handwashing and respiratory etiquette
- Physical distancing (2m)

Conditions

- Obligatory use of masks in public transport, schools, commerce and other enclosed spaces where there are many people
- o Maximum occupancy of 5 persons/100m² in enclosed spaces
- Decisions to be reviewed every 15 days

General Rules 04/05

- o Obligatory confinement for those who are sick and under active surveillance
- Civic duty to remain at home
- o Prohibition of events or gatherings with more than 10 people

o Funerals: with presence of family members

General Rules 30-31/05

 Religious ceremonies: community celebrations in accordance with rules to be defined by the DGS with religious entities

Public Transport 04/05

- Maximum occupancy of 2/3
- o Disinfecting and cleaning
- Obligatory use of masks

Employment 04/05

• Work should continue to be done remotely wherever the job permits

Employment 01/06

o Partial teleworking, with phased schedules or mirror teams

Public Services 04/05

- Decentralised counters open to the public (tax offices, town councils, etc.)
- By appointment only

Public Services 01/06

Citizens' Bureaux

Retail and Food Service 04/05

- Local retail: shops on the street of up to 200m²
- o Bookshops and automobile-related business, regardless of the type
- Establishments provided personal care services (hairdressers, barbers, manicures, pedicures and the like) by prior appointment

Retail and Food Service 18/05

- Shops on the street of up to 400m² or parts of shops up to 400m² (or larger by decision of the authorities)
- o Restaurants, cafés and bakeries, with maximum 50% occupancy
- Squares/esplanades

Retail and Food Service 01/06

- Shops with area larger than 400m2
- Shops inside shopping centres

Schools and Social Equipment 18/05

- o 11th/12th year or 2nd and 3rd year of other educational systems (10h-17h)
- Social equipment for special needs

Creches (with option of family support)

Schools and Social Equipment 01/06

- o Creches
- o Pre-school
- ATLs (educational support)

Culture 04/05

Libraries and archives

Culture 18/05

o Museums, monuments and palaces, art galleries, exhibition halls and similar

Culture 01/06

 Cinemas, theatres, concert halls, auditoriums (with numbered seating, reduced occupancy and physical distancing)

Sport 04/05

o Individual sport outdoors (without use of locker rooms or swimming pools)

Sport 30-31/05

o Football: Official competitions for Premier League and Portuguese Cup
